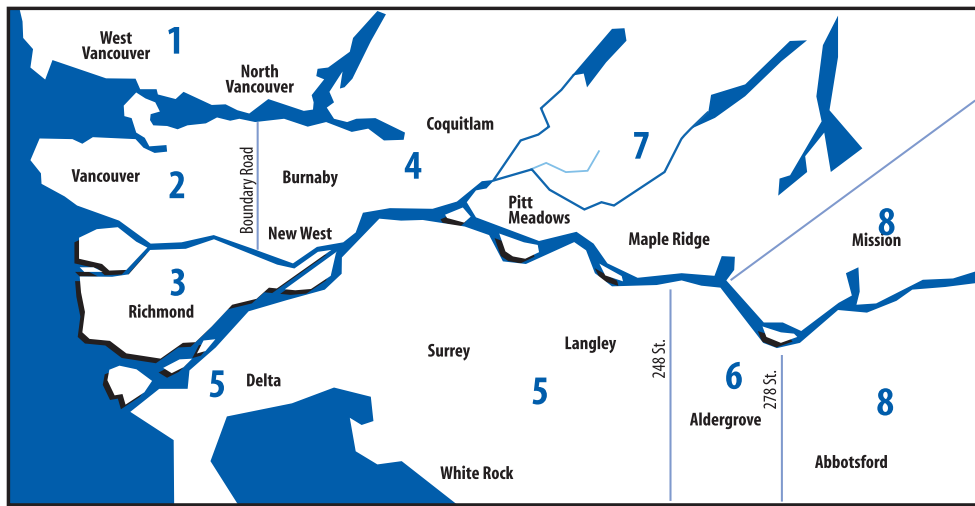

Terms & Conditions

- Base rate: STANDARD SERVICE - 0-20 lbs., \$0.09 per pound after 20 lbs.
2 HOUR RUSH SERVICE- 0-20 lbs., \$0.12 per pound after 20 lbs.
- Shipments will be priced according to cubing guidelines which are the greater of actual weight or dimensional weight. The dimensional weight is calculated by: length x width x height = weight (in lbs.) all divided by 115
- Maximum weight of 100 lbs. per item.
- Declared Value: \$100 free valuation included with every shipment (except those accepted at 'shipper's risk'). Declared values in excess of \$100.00 subject to a 3% fee. Declared values up to \$10,000.00 on In-City shipments charge account only. Shipments with a declared value between \$1000.00 and a maximum of \$10,000.00 must have pre-authorization from National Customer Service. Non-charge account shipments declared values up to a maximum of \$1,000.00.

Door-to-Door Shipments

- When the carrier has attempted delivery on two (2) occasions, without success, the carrier will notify the consignee with the following options:
 - (1) The consignee will pick up the shipment at the carriers agency/terminal, OR
 - (2) For delivery, or each additional attempt of delivery to the consignee an additional charge will be assessed.
